


"CLEAR ALTS" COLLECTION

We have a unique database which we call our "clear alts." That is inhouse shorthand for "alternative suggestions that have cleared in the past and might be useful for recycling someday." When we read scripts and find items that might present conflicts, our practice is to send 2 or 3 suggestions for alternate names for clients to use instead. This is a huge time-saver for productions that are working with short deadlines. At this point we have, for example, well over 400 periodical titles that have cleared in the past from which we can pick to help expedite a request such as: "We need a fake Hollywood gossip-type magazine title" or "We need a scholarly medical journal to show on the doctor's desk." We check 8 different sources to make sure that featured periodical titles are fictional, so the more options we have on-hand that worked in the past, the faster (and cheaper) it will be to re-check them and get a quick answer to art department. They are usually in a hurry!



We prepare research reports -- a.k.a. "title searches" on what's out there that might present a conflict with the title you intend to use for your production. Until a few months ago, our standard advice on the need for separate title search opinions to our Canadian clients was: We've never heard of a Canadian production needing a separate legal opinion on a title search. [The need for those opinions in the U.S. has been the norm for many years.] There has apparently been a change in what Canadian e&o providers are requiring. Many Canadian clients are now asking us to send them not only our research notes but an opinion as well. This opinion can't come from the research company, it must come from a lawyer who will charge a separate fee for it. We've put together a list of lawyers in Canada to whom we can refer you for these opinions. That information is now on our title search rate sheets. If we are the first to break this \$\$ news to you, we are sorry...

BIG SCREEN:The Colony - Laurence Fishburne leads the cast of humans fighting off feral cannibals in this sci-fi survival drama set in "the ice age."
